GRADE TYPE: All Washington Semester students will be registered for a letter grade in all courses (seminars, Research Project, internship, and elective courses). If you are from a member school, you must submit a “Request for Permission to Register Pass/Fail” form along with your registration form. This form should be obtained from and signed by your Faculty Representative to register for any course(s) on a pass/fail basis. Please note that your home school may convert your grades to pass/fail in transferring them to your home school transcript if necessary. The letter grade will, however, remain on your American University academic records. Pass/Fail grades cannot be changed to letter grades after the semester ends.

Remember that if you enroll in an elective course, it must meet after 5:00p.m and be between the 100 and 500 level.

NOTE: Students in the Contemporary Islam, Peace & Conflict Resolution, International Environment & Development, International Business & Trade: China, and International Law & Organizations semesters are NOT eligible to enroll in elective courses on main campus.

***RESEARCH PROJECT** is optional only for students who have permission to register for an elective in lieu of the Research Project and for students from non-member schools. If you wish to replace the Research Project with an elective course and have not already done so, you must see the Washington Semester staff during the first week of classes to drop the Project and add an elective.

**** TRANSFORMING COMMUNITIES STUDENTS:** Please state on your registration authorization form your choice of Government or Justice credit for the Transforming Communities Semester.
