Immigration & Latino Families

- "Immigrant" = "Foreign born" - includes naturalized citizens, lawfully present non-citizens, undocumented immigrants
 - 43.2 million foreign born (13.4%)
 - 44 percent are naturalized, 27 percent have a green card, and 25 percent are undocumented
 - > 86.4 million (27% of US population) in a household with at least one foreign-born person

- Latinos currently are the largest foreign-born population
 - 45 percent of immigrants reported Hispanic/Latino origin
 - 27 percent from Mexico (11.6 million, largest by far)
 - Another 8 percent from Central America, 7 percent from South America

Attacks on Immigrants & Their Families


- Increased enforcement: Arrests last fiscal year up 25 percent, including up 40 percent of some year-to-year rates after inauguration
- Elimination of priorities: anyone can be a priority
- Lack of discretion, leading to high-profile deportation of parents
- Rhetoric of immigrant youth, especially Latinos and Muslims, as criminals



Attacks on Health, Benefits, & Family-Based Immigration

- Draft Proposed Rule (not filed yet) would change definition of public charge test
 - Apply more broadly to many programs, including Medicaid, CHIP, & Head Start
 - Apply not just to immigrant, but to use by family members
 - Families choose between reuniting and obtaining necessary services
- Field manual for officers abroad already changed


