Testing and Assessment Summary

- 1. Shall test the actual mitigating effects after barrier is constructed using a science-based assessment developed by the University's acoustical engineers.
- 2. Shall evaluate all likely and reasonably anticipated sources of noise and other measures that could further reduce objectionable noise.
- 3. Shall share results with the Commission and 4710 owners before conditions on field usage and noise are modified and before any material changes to the design or usage of Jacobs Field that would increase noise are undertaken.



Analysis Requirements Summary

- Anticipated noise mitigation benefits.
- Performance measures or standards adopted to define an adequate or successful mitigation outcome.
- Noise impacts of any proposed changes to usage of Jacobs Field.
- The noise impacts at different locations on the 4710 property.
- Recommendations to further reduce the adverse noise impacts.
- Sharing of data, methodologies, analyses, reports, and assumptions with the 4710 owners before the University applies for any modification.





Existing Conditions




- The Reeves Field grass surface system has failed and is no longer functioning as required.

Note: Closure of Reeves Field was already expected because of the Meltzer Center/SCAN project.




Site Safety and Control Measures (Phase I)

Site Safety and Control Measures (Phase II)






