The Office of Equity and Title IX leads the university's efforts to prevent and respond to sexual misconduct, harassment, and discrimination on the basis of race, color, national origin, sex, sexual orientation, gender, genderidentity, gender expression, pregnancy or parenting, age, religion, disability, or other bases underfederal or local laws and regulations.

## Filing a Report with the Office of Equity & Title IX

- > You may make a report with the University's Equity and Title IX Office by submitting a report online.
- The Office of Equity and Title IX ensures that all community members receive appropriate resources, support, response, and reporting options to eliminate and address sexual misconduct, harassment, and discrimination.
- > The range of responses available through the Office of Equity and Title IX include:
  - Supportive Measures academic support measures, housing support measures, no contact orders, ensuring access to counseling and medical services.
  - Informal Resolution voluntary and does not lead to discipline.
  - Formal Resolution (Investigation) to determine whether a university policy has been violated.
