- AU has failed to take responsibility for its students in the past and has recently
 produced a new student code of conduct. Insufficient time has passed to know
 how effective it is and what attention is needed
- AU's ANC commissioners have not demonstrated positive leadership
- Need more focus on Tenley Campus, those plans need to be vetted by community to be affected
- Concerned about historic preservation surrounding Tenley Campus
- Some issues are broad and affect the entire community but some are smaller and only affect some neighborhoods, the process must give every neighborhood a chance to speak to their local issues
- Students need to understand that they are guests in the neighborhood
- There needs to be a dedicated and well publicized number that is operational 24 hours a day to report incidences of bad behavior in the neighborhoods
- Inconsistent policy surrounding preservation of green areas
- AU has to do something about the growing traffic problems
