# \$18.11 BSBA Specializations Action: Change the specialization requirements

- O The Office of Undergraduate Programs has been enforcing a rule that the 12-15 credit hours for BSBA specializations must be at the 300-500 level and may not include independent studies nor internships. The last point this was mentioned in a catalog was in the 2010 -2011. It appears that it was removed from the catalog after this time unintentionally due to a desire for brevity.
- O After consulting with each Department Chair, it became clear that <u>some departments wish</u> to allow independent studies towards a specialization. Therefore, the proposed change to the catalog copy for BSBA Specializations is in red below:

Specialization (12-15 credit hours)
Kogod students select an area of specialization from the approved programs below or design a custom specialization with the assistance and approval of their academic advisor. Specializations are 12 credit hours, with the exception of finance, which requires 15 credit hours. Specialization courses must be at the 300 level or higher and may not include internships. Certain specializations may permit up to 3 credits of Independent Study towards the specialization where noted. Students who choose to pursue two specializations must complete a minimum of 12 credit hours (or 15 credit hours for finance) for each specialization. With the approval of the Office of Academic Programs, BSBA students pursuing a second major may fulfill a custom specialization with courses from their non-KSB major coursework.

# 3. Title IX Discussion and Training, Regina Curran, AU Title IX Program Officer [A1]

 Presentation covered Title IX purpose, definitions, obligation of faculty as "responsible employees", policies, and guidelines. Further information is provided in an appendix to these minutes.

# 4. The Conversation, Katya Popova, Kogod Director of Strategic Communication

- O Katya invited faculty to join *The Conversation*, an independent, not-for-profit media outlet that uses content sourced from the academic and research community, with the goal of increasing Kogod's brand as a place where people go for guidance and inspiration. Currently Prof. Bruckner and Terjesen have contributed.
  - **Original Faculty Content:** The Marketing staff would like to engage all faculty in producing original content for *The Conversation*, a hub for content for many nationally-recognized media outlets. Content is free to re-publish and no changes to the content are allowed in the re-publishing process.
  - Continued Public Relations Effort: We will continue to leverage American University's central marketing expertise on connecting Kogod faculty with specific media outlets and responding to media requests for expertise.
  - Research Release Support: Faculty research will be assigned campaign workflows
    for publicity and dissemination to best leverage owned media, such as social media
    presence, and earned media, such as media outlets.
  - May 1<sup>st</sup>, 2018 Kogod will begin our contract with The Conversation.
- o The Conversation:
  - Their average 90 days in numbers:
    - 20.39 million readers,460 articles, 44,300 reads per article, (average), 21 republishers per article, (average)
    - Increase in Faculty Google Citations: Because all original content can be linked to the research being cited within the article, original research can gain valuable exposure for citation purposes.

- **Ability to Understand Reach:** Sophisticated dashboards showcase where content has been shared, engaged with, and read. Additionally, dashboards provide school-level understanding of author and content success.
- National Research Reach: By writing once, faculty can reach audiences in many publications. Articles are republished in large national outlets such as The Washington Post, Time, Newsweek, CNN, Univision, and many more.
- O Join *The Conversation* introductory training session on April 26<sup>th</sup> in Kogod with 1-2 editors and 2-3 representatives will be on campus. 3 hours sessions.

# 5. FedTech Program, Prof. Bill Bellows

- O 3-Credit Unique Independent Study Courses: MGMT 390 and MGMT 690 For graduate and undergraduate students interested in an intensive immersion in technology entrepreneurship, the partnership of AUCI and FedTech provides a unique opportunity to work with leading scientists and business people to commercialize patented federal technologies through customer discovery and use the technologies to start their own companies.
- o What is Fed Tech?
  - Up to three interdisciplinary teams of Kogod Students + CAS Students (3-6 students)
  - Participate with 35 other Entrepreneurs, Scientific Researchers, Inventors and other students
  - Assigned Patented Intellectual Property Developed in one of 25 Federal Research
     Labs
  - Engage in intensive 8-Week Customer Discovery Process to Commercialize the Technology
  - Final presentation hosted at Booz Allen Innovation Center with Booz Allen, attended by government and investors
  - Teams report results and present to inventors at Federal Labs
  - Can license the IP for low cost to start their own company
  - Can move from FedTech and apply to AU NSF iCorps Program for further research

#### 6. Council Report, Profs. Heather Elms and Mark Clark

- o Heather's time as Council chair is ending and Mark Clark is stepping up from vice-chair.
- o Nominations for vice-chair are needed.
- O Heather reminded people that Kogod Council is not "just a meeting", but a general process where faculty discuss a variety of issues including curriculum (they are working on changing how the forum runs the EPC portion). Revision to the by laws is needed to change how the voting is done.
- O Heather stresses the need for faculty to show up to the meetings, that are less than 2 hours per month. We have make this a stronger community and to have the numbers to establish a quorum.
- o Report for school year 2017 2018:
  - Curriculum: EPC actions
  - Tenure promotions policies and procedures, this extents to Term faculty –
     Reconciliation between policies still underway, it's still with RTC. Term faculty committee is currently working on revisions on term policies and procedures.
  - On matters and policies of general and strategic interest to the faculty and to KSB

Student ventures will be "tabling" in the hallway outside AUCI. Faculty will have the opportunity to walk

around, review material, and listen to 1 minute pitches by the ventures, engage in Q&A, and then fill out

a scoring sheet to rank the pitches. You are encouraged to meet with as many ventures as possible. Ventures will be divided into 2 categories for scoring: Revenue/Grant Generating and Pre-Revenue.

First place winner in the Revenue/Grant Generating category will receive \$1,000. Second place will receive \$500. First place in the Pre-Revenue category will receive \$500 and Second place \$250.

#### **Council Voting Procedures**

**Device**: Smartphone and laptop/tablet (no "dial up" phone)

Adrian has created a text number "22333" (text "kogodcouncil") and a web site page, www.POLLEVERYWHERE.COM/KOGODCOUNCIL to facilitate voting.

Both permit easy voting. Once you've texted "kogodcouncil" to 22333, you'll be able to text A, B, or C, according to the Yes/No/Abstain vote as indicated on the Council Meeting PowerPoint. Similarly, once you've bookmarked and opened the webpage, it automatically shows your choices.

Adrian can open, tally and close a poll easily. The web page updates the status and your options. We believe the most efficient procedure is to create a generic "Yes / No / Abstain" poll and activate it as required.

#### Presentation of the action at Council

The action under consideration will appear in the PowerPoint screen in KSB 118 as we've done in the past. To simplify matters, any editing or construction of a motion will be done directly "on screen" in 118 using the power point slide. Separating the "vote" page from the "motion" slide seems to be operationally quick and simple.

### Establishing Quorum and The Baseline for Passage of an Action

Quorum count. Attendance will be confirmed two ways at the beginning of Council: normal headcount and by asking all members to e-vote "Present" (by smartphone/iPad/laptop) and by initial sign-in for any paper ballot. This paper ballot option is reserved for those who are physically present and wish to vote by ballot rather than smartphone/iPad/laptop/ PLUS those who hold a proxy for another member. (Adrian will create a "Vote Present" poll for this opening exercise for the quorum count.)

The attendance head count defines the baseline (a quorum requires 51% of KSB full-time faculty to be physically present) and thus the "hurdle" (67% of those present) for passage of any general vote taken at that Council. **If required,** a second "Present" vote may be taken for restricted votes (e.g., only tenure-track faculty are eligible to vote on certain issues).

#### Phone dial in

At this time we have no simple and reliable system for members who listen via phone. (If you are a multi-tasker presenting at an academic conference and listening to Council, you have the option of requesting a proxy ahead of time.)

#### **Side Comments / Issues**

- 1. Risk of double voting. To maintain anonymity we will not collect a name or id. Thus, we cannot prevent someone from voting via laptop and also a second device such as a smartphone. We are on an honor system.
- 2. Dropped internet connections while you are home / off site. There is no 'back up' system. A lost internet connection during a Council session means a lost vote. (Note, the hurdle remains the same since it may be too troublesome & time consuming to repeat the "All Present Vote" routine before every action vote.)

# **APPENDIX: Title IX Presentation, April 2018 KSB Council**

# Discussion led by Regina Curran, AU Title IX Program Officer

- Title IX prohibits recipients of federal financial assistance from discriminating on the basis of sex in education programs or activities.
  - o Sexual harassment, including acts of sexual violence, is a form of sex discrimination prohibited by Title IX.
- "Responsible employee" (2001 OCR regulations)
  - O AU Community members <u>employed by the university</u> (including student employees such as teaching assistants, resident assistants, and orientation leaders) have a duty to report Prohibited Conduct to the appropriate Designated Official, when they become aware of such conduct. (AU's Discrimination & Sexual Harassment Policy and Procedures)
- Why does Responsible Employee reporting exist?
  - O Two main goals: 1. Provide a comprehensive and accurate list of resources and reporting options to all reporting parties (including the option to file a criminal report if the student chooses). 2. Identify and address systemic patterns of discrimination and harassment
- Title IX Prohibits
  - O Sexual Harassment, Rape, Sexual Assault, Sexual Exploitation, Dating & Domestic Violence and Stalking
- Title IX Program Office information: Regina Curran (<u>rcurran@american.edu</u>) and Title IX website (<u>www.american.edu/titleix</u>), Butler Pavilion 4<sup>th</sup> floor.
- What does Title IX require you to report?
  - o The names of the alleged perpetrator (if known)
  - o The name of the student who experienced the alleged sexual violence
  - Other students involved in the allege sexual violence
  - o Relevant facts: including date, time, and location (if known)
  - You should not "investigate", only report what you know.
- You receive a disclosure, now what?
  - o Thank you for telling me.
  - o I need to let you know that I am responsible for reporting to the University... (goal is transparency and reducing surprise/distress, not to discourage reports)
  - o Confidential resources
  - O OCHO[A2]
  - o OASIS Wellness Center, Hughes Hall
  - o Counseling Center MGC 2<sup>nd</sup> Floor
  - o Health Center McCabe Hall
  - Ordained chaplains in Kay Spiritual Life Center (13 individuals)
- What happens after you report?
  - o Outreach (100%)
  - o Every single victim/survivor will receive outreach from Title IX
  - O Students may choose to respond or not (non-responsive students will receive comprehensive list of resources and reporting options)
  - o Intake
  - o Informational meeting to learn about resources/options and ask questions
  - o Accommodations
  - o Academic, housing, no contact orders, etc.
  - o Investigation

- o To determine if the other party has violated University policy
- Title IX and Kogod
  - o 10% of all students involved in Title IX reports received in AY2017-2018 are enrolled in Kogod
  - O Reaction/response of those who receive disclosures has a significant impact on future help seeking by those experiencing sexual violence, relationship violence, and stalking
  - o Interim measures and supports enable students who have experienced violence to remain enrolled and moving toward degree completion
