## 2. Comments from Dean Delaney

- Endorsing Study Aboard for students
- How will we differentiate Kogod from other business schools? Hard work ahead when it comes to Grad Student Enrollments
  - O Huge interest in Sustainability Management.
  - Flat or declining interest in many of the other programs. Kogod must watch this
    progression and is requesting help from faculty in converting students as we move into the
    next cycle.
  - o The Dean requests the help of faculty in the recruitment of grad students.

## WeWorks

- The Dean addresses the question whether Kogod is promoting WeWorks and is the cooperation too much .
- He starts his remarks by referring to WeWorks' recent problems but still sees the shared-space industry as a thriving opportunity for us.
- o In fact, Kogod has a couple of unique connections with the company which will help us in this endeavor.
  - Our goal is to continue moving things forward. Specifically, we are making really
    good progress with the matching technology by AstrumU which the Dean has
    mentioned before to everyone. He is hopeful to demonstrate the technology in one

- of the coming council meetings. Its purpose is to match thousands of students with thousands of jobs in a matter of seconds. This technology will give us the ability to replicate WeWorks at a higher level.
- Kogod is also looking at a number of other possible strategic partners. What we are trying to achieve at WeWorks, we can also realize with those firms. Our main goal is to generate opportunities for our students and use the results to generate reputational advantage for the school all the more so that we are the primary university partner in this endeavor. We have hired a new staff member as the lead person for the WeWorks incentive; she will start later this month. The position was set up for one year to see what we can do with WeWorks. The Dean expects the initiative to be successful. Some faculty expressed concerns that cooperating with WeWorks might not reflect well on us, if only because the company features prominently on the monitors in the Kogod building. As a result, we may have to update the way we are representing our involvement with WeWorks. The Dean feels strongly that the shared space industry is going to continue to make great progress and represent opportunities for Kogod and its students.

- Since the Dean has development meetings are coming up he is unfortunately obliged to cancel some meetings. He kindly requests to bear with him; everything will be rescheduled. The purpose of the meetings with donors before the year ends is to see if Kogod can close some year-end donations.

    - KSB 1.8 million

# F19.06 MGMT-477/677 Blockchain Applications Action: Create new cross-listed courses

- o This cross-listed course will enable students to develop basic competency in the fundamentals of this emerging technology and to learn how it will disrupt business and social processes in myriad arenas. It will also provide experiential learning through a live blockchain project working with local companies.
- o The course will be a stand-alone elective.
- o It has been offered twice before (in Fall 2018 and Fall 2019) and worked very well in accomplishing its learning objectives as measured by the outcomes of the projects that were done and the Input on Teaching from Students.

- Thoughts?
  - One faculty member asked: How do we engage with other groups around the city?

- Response There will be a meeting with the Center for Community Engagement. Prof. Grier has already spoken with Marcy Campost; the Center has connections with many non-for-profit groups that we can work with. We can also see if we want to invite different people from various groups that are engaged in activities important to us? What are the topics that Kogod wants? Some students may want to do a Podcast around a certain class topic. Perhaps have a Potluck in the Marketing suite? There are many different ways everyone can think about coming together.
- Sonya's team has already received an email from Prof. Don Williamson who wants to do a "Tax talk".
- O Another faculty member was very excited about joining this initiative. They want to connect this group with their "Committee Tax Aid", because they run "The Washington Initiative", which is one way that we might reach a diverse population of low-income taxpayers throughout the DC metro area. Kogod students are trained in preparing tax returns and go and help these taxpayers. They would be very happy to promote this kind of initiative with that population, who also have a great network in the underserved community.
- O Another member requests to be kept informed of this new initiative. But how?
  - Yes, we will be sharing information with faculty as it becomes available. A Communications firm is developing the strategy, branded materials, but so far none of that is ready. Prof. Grier wants everyone to be aware of this new Kogod Strategic Initiative from its infancy. She also wants everyone to think about it over the holiday break, to see if their students would be interest in participating. Maybe it would be possible to build a class assignment using this initiative? Perhaps write a case study based on this project about the partnership and how one would evaluate businesses engagement in social issues as well? There is a lot that we can do with this project. It is also nice that the community foundation is paying for most of it.

## 6. Additional announcements

- SR. Assoc, Dean Adhikari Scheduling/coordination of IBUS courses, post the dissolving that the department.
  - o Unfortunately, some IBUS classes were inadvertently missing from the department chairs' schedules
  - The question then becomes how do we avoid classes slipping through the cracks (e.g., courses where there are multiple sections taught by faculty in more than one department).
  - One idea: IBUS courses cross-listed with another department. Example: IBUS/MKTG
    for the International Marketing course. Such crosslisting will make it clear which
    department oversees that class.
  - Kogod is examining those options, but taking this route will require a lot of coordination with the Registrar. We are awaiting feedback from them. Once we have heard back, we will proceed with our next step.
  - O IBUS 300 is a very important course for us, because it is one of AU's Habits of Minds. Also, it is one of the highest enrolled classes for Kogod, so we need to take better care of this class.

## **Council Voting Procedures**

**Device**: Smartphone and laptop/tablet (no "dial-up" phone)

Adrian has created a text number "22333" and a web site page, www.POLLEVERYWHERE.COM/KOGODCOUNCIL to facilitate voting.

Both permit easy voting. Once you've created the first text message to 22333, texting is simple. Similarly, once you've bookmarked and opened the webpage, it automatically shows your choices.

Adrian can open, tally and close a poll easily. The web page updates the status and your options. We believe the most efficient procedure is to create a generic "Yes / No / Abstain" poll and activate it as required.

#### Presentation of the action at Council

The action under consideration will appear in the power-point on screen in KSB 118 as we've done in the past. To simplify matters, any editing or construction of motion will be done directly "on screen" in 118 using the PowerPoint slide. Separating the "vote" page from the "motion" slide seems to be operationally quick and simple.

## Establishing Quorum and The Baseline for Passage of an Action

Quorum count. Attendance will be confirmed two ways at the beginning of Council: normal headcount and by asking all members to e-vote "Present" (by smartphone/ipad/laptop) OR by initial sign-in for any paper ballot. This paper ballot option is reserved for those who are physically present and wish to vote by ballot rather than smartphone/laptop/pad PLUS those who hold a proxy for another member. (Adrian will create a "Vote Present" poll for this opening exercise for the quorum count.)

The attendance headcount defines the baseline and thus the "hurdle" (67%) for passage for any general vote taken at that Council. **If required,** a second "Present" vote may be taken for restricted votes (e.g., only tenure-track faculty are eligible to vote on certain issues).

#### Phone dial-in

At this time, we have no simple and reliable system for members who listen via phone. (If you are a multi-tasker presenting at an academic conference and listening to Council, you have the option of requesting a proxy ahead of time.)

#### **Side Comments / Issues**

- 1. Risk of double voting. To maintain anonymity, we will not collect a name or id. Thus, we cannot prevent someone from voting via laptop and a second device such as a smartphone. We are on an honor system.
- 2. Dropped internet connections while you are home / off-site. There is no 'back up' system. A lost internet connection during a Council session means a lost vote. (Note, the hurdle remains the same since it may be too troublesome & time-consuming to repeat the "All Present Vote" routine before every action vote.

## **Summary**

With a computer or other internet capable device (e.g. iPad, Android tablet): go to <a href="mailto:pollev.com/kogodcouncil">pollev.com/kogodcouncil</a> and select the response. Please bookmark the page for future use. At the beginning of the Council meeting we'll run a count to establish the quorum, please click on the "Present" button at the beginning of the meeting to get counted.

If you do not have access to a computer, you can use a phone to text the code corresponding to your chosen response to 22333.

Instructions for texting the response:

- 1. Start the text messaging application on your phone
- 2. Enter 22333 for the recipient address
- 3. Type KOGODCOUNCIL in the content field and press Send to join the session4. After you joined the session, you can enter the corresponding letter (A, B, or C) for the response (the letters will be projected on the screen next to the response alternatives) and press Send.

For people responding by SMS it basically introduces a new step, they will need to text "kogodcouncil" to join the session, then things will be easier because the choices can be "A", "B", "C" or "1", "2", "3" instead of a long random number. The system is also nicer and easier to use from the point of view of the person who conducts the poll.
