#### Abstract:

Charles McHugh served as a physician with the Peace Corps between 1965 and 1967 and contributed to a medical examination during the 1966 murder trial of Peace Corps Volunteer William Kinsey in Tanzania. This collection includes Charles McHugh's records and personal notes, correspondence, testimonies, communications, in addition to collected newspaper clippings, related to his work on the medical examination of a deceased Peace Corps Volunteer.

## **Collection Description**

#### **Biographical Note**

Charles McHugh (1937-2022) was born in New Jersey and graduated from Wesleyan University with degrees in Biology and History in 1960. He later earned his MD from Albany Medical College in 1964 and interned at the University of Chicago Hospital. After finishing his internship, he served as a doctor and surgeon for the Peace Corps between 1965 and 1967 in Tanzania. During his service in Tanzania, McHugh contributed to the medical examination of the deceased Peace Corps Volunteer Peverley Kinsey as part of the 1966 murder trial of Peace Corps Volunteer William Kinsey. McHugh later served as Vice President for Medical Education at Columbus Cuneo Cabrini Medical Center in Chicago between 1972 and 1979 and had a private General Surgery and Family Medicine practice until his retirement in 1986.

#### **Collection Scope and Content Note**

The collection includes Charles McHugh's records and personal notes, correspondence, testimonies, communications, newspaper clippings, and medical notes documenting his work on the medical examination of the deceased Peace Corps Volunteer Peverley Kinsey during the 1966 murder trial of Peace Corps Volunteer William Kinsey in Tanzania. McHugh also aided the local doctor in his examination for the trial. The collection includes the autopsy and notes, copies of official reports given to the police and the courts, and the correspondence related to the trial are between Charles McHugh and the Peace Corps, the local law enforcements, and the parents of William Kinsey.
