ABOUT WILLIAM K. REILLY

William K. Reilly is one of the most respected environmental leaders in the country. From 1989 to 1993, Mr. Reilly served as the sixth Administrator of the U.S. Environmental Protection Agency under President George H.W. Bush, where he was recognized for outstanding qualities of leadership and the ability to achieve results. In 2010, President Barack Obama named him as co-chair of the bipartisan National Commission on the Deepwater Horizon Oil Spill and Offshore Drilling. Among his other positions are the President of the World Wildlife Fund, President of the Conservation Foundation, and Founding Partner of Aqua International Partners, a private equity fund investing in companies in the water sector. He currently is Senior Advisor to TPG Global, LP, and Cochairman of the Bipartisan Policy Center Energy Project and of the Board of the Global Water Challenge.
