The Center for Environmental Policy at American University's School of Public Affairs, the Children's Environmental Health Network, and the Woodrow Wilson International Center for Scholars present ***The Social and Economic Costs of Climate Change on Children's Health: What Do We Know and What Can We Do?*** This half-day forum will address the social and economic implications of and strategies for addressing the impacts on children's health resulting from climate change.

This event will include discussions with policy experts, representatives of environmental organizations, public health experts, and economists. It will address the current state of knowledge of the impacts of climate change on children's health and steps for mitigating them. Discussion and findings will be summarized in a report that will incorporate recommendations for next steps as well as follow up activities and commitments by the participants.
