MANUSCRIPT

"Setting the Foundations: Black Women's Labor as a Cornerstone of Oral History at US Institutions" contributes to growing literature recognizing more complex histories of the field. It centers Black women's labors in early institutional oral history projects/programs by focusing on individuals in pivotal roles at universities in the early- and mid-1900s, and at community-based institutions even earlier. By specifically focusing on Black women, this project emphasizes their roles in establishing, "professionalizing," and advancing oral history as a methodology and field. It highlights Black women working simultaneously alongside and in resistance to Whiteness, disrupting dual notions that institutional oral history's origins were primarily White and primarily male.
