Proposed the idea in October 2007; approved by the University in March 2008. The award-winning Investigative Reporting Workshop in its first decade of publication has reported and published dozens of major investigative reporting projects and more than two hundred news stories, co-published with at least 28 media partners, including the PBS program FRONTLINE, *The Washington Post* and WAMU.
- To date, the IRW has co-produced 12 FRONTLINE documentary programs, and one documentary that was part of an Emmy Award-winning 10-hour series that aired on Showtime. Workshop researchers also helped to research two books: *The Betrayal of the American Dream* by Donald L. Barlett and James B. Steele (PublicAffairs; 2012), a *New York Times* bestseller; and *935 Lies: The Future of Truth and the Decline of America's Moral Integrity* by Charles Lewis (PublicAffairs; 2014).
- IRW has hired more than 15 experienced reporters, editors and freelancers to work with the IRW editors and students. Workshop internships, fellowships and post-graduate fellowships have resulted in the hiring of more than 160 students from AU and other universities.
- Since its inception in mid-2008, the Workshop has raised/received \$15,906,856 from grants, donations and earned revenue. It is the largest research center within the American University School of Communication, one of the largest at AU and the only one of its reportorial ilk within the Washington D.C. metropolitan area's 13 colleges and universities.
