

# LL.M. PROGRAM

The LL.M. in Law and Government is an LL.M. with a difference. Designed for both domestic and international law graduates who have a strong interest in U.S. government and politics, the dynamics of democracy, and the meaning of the rule of law, the LL.M. in Law and Government takes students on a broad and deep examination of the most important public policy issues of the time. Our organizing educational principle is that the best prepared lawyers and analysts in fields of regulatory law not only have a firm grasp of particular subjects, but also a mastery of the theories, political forces, and institutional realities that define public law in the United States.

# MARSHALL-BRENNAN CONSTITUTIONAL LITERACY PROJECT

Named for the late U.S. Supreme Court Justices Thurgood Marshall and William J. Brennan Jr., the Marshall-Brennan Constitutional Literacy Project at American University Washington College of Law provides rigorous training in constitutional law and pedagogy to law students who serve as Marshall-Brennan Fellows and go out to teach in District of Columbia public high schools. Fellows work with teachers, administrators, and lawyers to teach students about their rights and responsibilities, the benefits of political participation, and the lawmaking and adjudication process. The Project was founded in 1999 by Professor Jamie Raskin, who was elected to the U.S. Congress in 2016. Since its founding, 19 law schools across
